WLH HOSTS SPECIAL EVENTS LIKE BIRTHDAY CELEBRATIONS, A SUMMER LUAU, AN UNFORGETTABLE CHRISTMAS PARTY, TEEN GATHERINGS, AND MORE. HEROES ALSO RECEIVE ACCESS TO MEMBERSHIPS WITH LOCAL ZOOS, MUSEUMS, AND ART THERAPY PROGRAMS, ALONG WITH OTHER ENRICHING ACTIVITIES.
