



Special Event Liability Release Form

By participating in this Special Event you must understand that you will **participate at your own risk.**

1. **Assumption of Risk.** I expressly acknowledge that I, and my family, am participating in the Special Event and any or all of the activities involved with the Special Event completely voluntarily and in no way hold Wichita's Littlest Heroes responsible for any liability, injury, death or loss, involved.
2. **Agree to Supervise.** I agree to be responsible for any minor children that I have brought to this event. I agree that I will supervise them at all times. I further agree that I shall not allow any minor child under the age of 16 that I am responsible to go into the lake without 100% supervision from myself or another adult in my party.
3. **Waiver and Release.** I waive and release Wichita's Littlest Heroes and its Board of Directors and/or those connected with the event from all claims for any liability, injury, death, loss or damage in any way connected with or arising out of my participation in the Special Event.
4. **Indemnification.** I agree to indemnify and hold harmless (in other words reimburse and be responsible for) Wichita's Littlest Heroes and it's Board of Directors and/or those connected with the Special Event from all claims for any liability, injury, death, loss or damage in any way arising out of my participation in the event.
5. **Medical Attention.** I agree that Wichita's Littlest Heroes will not provide me with medical care or medical attention and that participation in the Special Event is totally voluntary and I, and my family, participate at my own risk.
6. **Binding Effect.** This instrument shall be binding upon my relatives, personal representatives, heirs, beneficiaries, next of kin, or assigns and shall inure to the benefit of Wichita's Littlest Heroes.
7. **Invalidity/Unenforceability.** If any provision of this instrument is held to be invalid or unenforceable, this instrument shall be construed as if such valid or unenforceable provision was not contained herein.
8. **Applicable Law.** Because Wichita's Littlest Heroes is located in Wichita, Kansas and in order to provide certainty in the law to be applied to the construction of this instrument, this instrument shall be governed, construed and enforced in accordance with the laws of the State of Kansas.
